**Section 1. Selling commission**

- a. The schedule of charges will be at rates pursuant to an Insurance policy on file with the Livestock Market and does not contain any charges retained by the market.

**Section 6. Special or Unusual Services**

- a. Special selling and marketing services, such as involved in featured, special cow, calf or registered cattle and calf sales, not usually required in handling livestock for sale or other than specified, will be charged for under special arrangements.
